4. Details of association of the above premises with serious crime, serious disorder or both (Please read guidance note 2)

This application relates to an incident of a serious disorder and Violent crime at the Red Rooms, 4 Great Queen Street, WC2B 5DG.

On Sunday 15th December 2019 at 05:00 hours, LAS called Police to reports of a Male being bottled with an injury to the victims head. This was then updated to 'a Male has been stabbed at location' Cris 2340145/19 and CAD 1618/15DEC19 Refers. The victim was with three friends, all are **Example 10**, arriving on 14/12/2019.

The victim stated that a verbal argument started between himself and the suspect. He then saw the suspect produce a pocket knife and then stab him in the face.

CCTV shows the argument, then the suspect picks up a glass tumbler from the bar, it is not clear where the tumbler ended up. The Suspect then makes downward stabbing motions after which blood is seen on the victims coat. The Suspect is then seen folding a presumed pocket knife and putting it in his trouser pocket.

Injuries sustained by the victim are a stabbing to his head, neck and back. The Victim is currently in an induced coma and intubated, due to surgery in order to stop the bleeding from his neck.

He is in a critical condition.

We have scrutinised Police indices and ther does not appear to be any record of a call made to Police by staff at the premises. This venue has recently come to Police notice and a Police representation has been made regarding the renewal of the Sexual Entertainment Venue Licence.

Given the serious nature of this incident the premises needs to be closed whilst investigations are undertaken and to ensure public safety and an immediate suspension of the licence is being sought".

Notes for guidance

- A certificate of the kind mentioned in the form must accompany the application in order for it to be valid under the terms of the Licensing Act 2003. The certificate must explicitly state the senior officer's opinion that the premises in question are associated with serious crime, serious disorder or both. Serious crime is defined by reference to section 81 of the Regulation of Investigatory Powers Act 2000. In summary, it means:
 - conduct that amounts to one or more criminal offences for which a person who has attained the age of
 eighteen and has no previous convictions could reasonably be expected to be sentenced to imprisonment for
 a term of three years or more; or
 - conduct that amounts to one or more criminal offences and involves the use of violence, results in substantial financial gain or is conduct by a large number of persons in pursuit of a common purpose.
 Serious disorder is not defined in legislation, and so bears its ordinary English meaning.
